- a. Funding Request Peter Fultz
  - Last June RVS devision shortage of money, cut backs on custodial staff, head building operator per 3 schools vs building operator/1 school, less funds in last fall budget, capped reduced 50%, new workflow for approvals.
  - Chrome books last 5 years. Grade 7-8 Chrome Books expire this year, Need loaner cart for students in Grade7-8.
  - New FI classes next year.
  - \$350.00/Chrome Book with warranty.
  - Evergreening: one of one program, this program has been cut back.
  - Charging cart \$3,000 purchased by Mr. Fultz. Estimation to replace 50 Chrome Books is \$21,000.00.
  - Charlotte: what happens to the Chrome books that are expired end of June and can't be used, Mr. Fultz: can't get security updates on them, they go back to RVS.
